The school undertakes to abide by the provisions contained in the affiliation & examination bylaws, directions issued from time to time and law of the land.
- 8 That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to school and staff of the school.

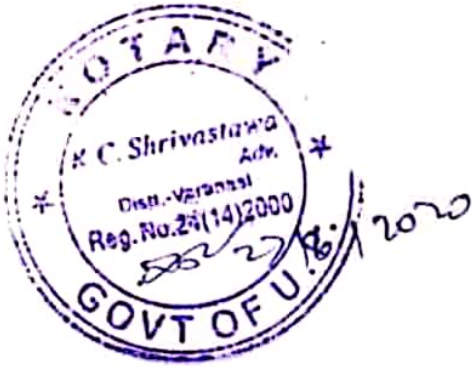
laws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the fee.
